I hope everyone had a great Thanksgiving and are planning for a Merry Christmas. Recently the pandemic has restricted our monthly Board meeting from allowing an open forum for residents. We are hoping to begin virtual meetings soon.

Since our last newsletter, we have made progress on several items:

- Three revisions to CC&Rs have been approved by residents: restricting home rentals, providing for clear access to fire hydrants and requiring yard lanterns to remain lit from dusk until dawn. We have received the revised CC&Rs from our attorney and they have been signed and notarized. Next, they are filed at the courthouse and we will be communicating more information to residents shortly regarding timeframe and options to ensure compliance.
- You may have noticed that the Baystone entrance lights have been repaired and two new street lights were added. We intend on adding street lights to the Crossroads entrance as well. New pine needles have also been spread on all common area pine needle sections. This is done two times per year.
- We are working on new procedures for renting the Clubhouse that will be ready by the time we are able to open the Clubhouse to rentals again.

• On Saturday, December 5th, Santa visited the neighborhood and we were able to share coffee and donuts at multiple stops. Thanks to all of our amazing volunteers that made this another successful event even in these times requiring limited interaction.



CLUBHOUSE COMMITTEE

The Clubhouse remains closed until further notice due to the ongoing COVID-19 situation. The Board of Directors will keep everyone apprised of re-opening and when reservations will resume. This down time has provided an opportunity for the old leaking windows in the Clubhouse to be updated. New maintenance-free windows were installed in October. The project went smoothly and they look wonderful with last year's updated exterior.

Additionally, once the Clubhouse is reopened, there is a need for volunteers who are willing to inspect after rentals. The inspector's role is to verify that the Clubhouse has been returned to its original condition, cleaned, undamaged and with all furniture properly stored. A checklist of items must be reviewed and a few supplies restocked in preparation for the next rental.

Inspections will be time sensitive, typically occurring late on Fridays and weekends after rentals and/or early weekend mornings prior to the next day's rental. ARCHITECTURAL REVIEW COMMITTEE

The Porter's Landing Architectural Review Committee is responsible for maintaining and upholding portions of the Covenants, Conditions, and Restrictions (CC&Rs) of our neighborhood. It is the Committee's responsibility to review architectural requests from homeowners looking to make improvements to their property (for example, but not limited to, add a structure, fence, utility building, screen porch, playhouse, deck/deck extension, mailbox posts, and so on).

The CC&Rs and other guidelines can be found in the "Forms and Docs" section of https://web.mycmg.com/Home.asp. These were also included in your closing documents and required your signature.

Kurt Hagemann has "volunteered" to build replacement mailbox posts and scrolls for neighbors in need. Please contact Kurt at (cell) 704-930-9758 to discuss pricing and timing. An Architectural Request is not required for this replacement from Kurt.

Requests require prior approval before any project begins. Please plan in advance as the approval process can take up to 30 days. You can submit an architectural request by:
